The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.



CLEAR-BOR F.T. is an aqueous solution of borate salt for the protection and treatment of exposed wood surfaces during construction or fabrication, against Subterranean Termites (*Reticulitermes*, *Coptotermes*, *Heterotermes*), Damp wood Termites (*Zootermopsis*), Dry wood Termites (*Katotermes*, *Incisitermes*), Carpenter Ants (*Camponotus*), and Wood Decay Fungi. This treatment is not effective against Wood Staining Fungi and may require mixing with compatible products. CLEAR-BOR F.T. is recommended for all interior and exterior wood which will be protected from rain and not in direct contact with soil. This product is toxic to wood destroying insects but surface etching of treatment wood may occur.

FIELD TREATMENT APPLICATION

Field treatment on end cuts of treated wood during construction or fabrication for control of organisms that attack wood may be applied by brush, spray or dipping until surface is thoroughly wetted. Current American Wood Preservers Association specifications for end treatments should be followed to ensure adequate chemical loading in wood.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Do not store where children or animals may gain access.
