DIRECTIONS FOR USE
It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.
RECOMMENDED FOR COMMERCIAL/INDUSTRIAL USE.

AERO-SPRAYWIPE has been especially developed for use on horses. It provides a protective hair coating against flies while imparting a high sheen to the hair when brushed out. 1 to 2 ounces per head per day gives adequate protection. Apply by either soft cloth or fine spray mist.

WIPE ON USE:
First, brush animal to remove dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing against hair growth. Give special attention to legs, shoulder, shanks, neck, and facial areas where flies are most often seen. Only light application is needed. Avoid using an excess amount. Do not wet skin. After application, brush out thoroughly to bring out bright sheen on the coat. Repeat daily or as needed.

USE AS A SPRAY:
AERO-SPRAYWIPE may be applied as a fine spray mist to stable area and over and around stables for fast paralysis and kill of flies. Do not wet horse's skin or exceed two ounces per application.

STORAGE AND DISPOSAL

CONTAINER STORAGE: Do not store near heat or open flame.

DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
