

Prior to the use of Aqua Mate 282 industrial and/or commercial recirculating cooling towers should be cleaned to remove algal growth, microbiological slimes, and other deposits. Initial slug addition of 12.0 to 17.9 fl. oz. of Aqua Mate 282 per 1000 gal. of water to provide 100 to 150 ppm Aqua Mate 282, based on total weight of water. Slug additions should be made until control is evident. Make subsequent slug additions of 10 to 15 ppm Aqua Mate 282 every 2 to 3 days.

Slugs of 35.9 fl. oz. of Aqua Mate 282 per 1000 gallons of water should be employed every 1 to 5 days until control is evident. Slug additions should be made to the sump or the system.

Slugs of 21.0 to 35.9 fl. oz. of Aqua Mate 282 per 1000 gallons of water should be employed every 1 to 5 days until control is evident. Slug additions may be made to the sump or the system.

STORAGE AND DISPOSAL
