Dear Ms. Horton:

The revised labeling referenced to above, submitted in connection with the registration under the Federal Insecticide, fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable with the following comments:

- 1) Revise the Precautionary Statements to read "Harmful if swallowed, inhaled or absorbed through the skin. Do not breath dust. Avoid contact with eyes, skin or clothing. Wash hands with soap and water after handling. Remove contaminated clothing and wash clothing before reuse. Do not contaminate water food or feed with this product
- 2) The Note to Physician should be updated to read "Contains N-methyl carbamate insecticide which is a cholinesterase inhibitor. Specific antidote consists of atropine. Narcotics and other sedatives should not be used. Drugs like 2-PAM (pyridine-2-aldoxime methiodide) are NOT recommended.
- 3) The heading should read "Ticks that may carry Lyme disease. You must remove "dreaded" from the LYME Disease. You must remove amblyomnia spp as a vector of Lyme disease.

#### FIRST AID

IF SWALLOWED - Call a Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

Apply when insects first appear, and/or turf damage is threatened. When two rates are recommended use the lower rate for light infestations and the higher rate for insect damaged turf and for heavy insect infestations. For best results, mow lawn first and them apply material. After application apply % inch water by sprinkler irrigation to the treated area to release the insecticide and plant food. "See watering limitation for treating for Sod Webworms. Keep children and pets off treated areas until grass is dry. Repeat applications may be made for control of any new insect generation.

#### FOR CHINCH BUGS AND BUD WED WORKING

Apply 6.9 to 9.2 pounds of this product to treat 1,000 sq. ft. (which is equal to 300 to 400 pounds of this product per acre). These rates are equivalent to 6 to 8 pounds a.i. carbaryl per acre For Chinch Bugs treat entire area to prevent their migration to untreated turf. "For Sod Webworms do not irrigate treated areas for 12 to 24 hours after treatment. A repeat application may be required in 30 days if a new generation, of sod webworms, aggers.

## ROOT FEEDING INSECTS

ON GOLF COURSES, SOD FARMS, HOME LAWNS, AND RECREATIONAL TURFGRASSES:
FOR CONTROL OF WHITE GRUBS (SUCH AS JAPANESE BEETLE, CHAFER BEETLES, AND PHYLLOPHAGA
SPP. LARVAE), BLUEGRASS BILLBUGS, FLEAS, EUROPEAN CRANE FLY LARVAE, MOLE CRICKETS AND
BLACK TURFGRASS ATAENUS.

Apply 4.6 lbs. to 9.2 lbs. per 1,000 sq. ft. of turf area (equal to 4 to 8 lb. A.I. per Acre) during late March through May or July to early September when Grubs are feeding near soil surface or as recommended by local agricultural extension agents. See instructions in GENERAL DIRECTIONS paragraph. Sprinkler virigate furl thoroughly, (1/4 to 1/4 inch water), soon after treatment to move the insecticide into the root zone. For CRANE FLY LARVAE apply at the same rate in early spring, April 1 to April 15th or as recommended by the local Extension Service

## THE TREATMENT OF HOME LAWNS and TURFGRASS AREAS ON GOLF COURSES, PARKS, and RECREATIONAL AREAS will SIMULTANEOUSLY CONTROL the TICKS that VECTOR and CARRY the dreaded "LYME DISEASE".

For control of juvenile and adult bodes spp. (Deer Tick and Black Legged Tick) and Amblyomnia spp. Ticks (Lone Star Ticks) which vector LYME disease, apply 4.6 lbs. to 9.2 lbs. per 1,000 sq. (f. with appropriate equipment to ensure uniform coverage. Target your applications to control the young juvenile ticks (larvae and nymphs) in late spring or early summer (May/June). Control of adult ticks can be achieved with late summer and fall applications (Aug/Sept.). Make applications to lawns, shrub beds, ornamental plantings, around wooded areas on host animals. Retreat turf grass in 2 to 3 months or as necessary to maintain adequate control levels.
