Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SUPER ALGAE RAIDER is used to control the growth of algae in swimming pools. For maximum effectiveness pools containing heavy growth of algae should be cleaned prior to using SUPER ALGAE RAIDER.

For pools having just visible algae growth add an initial dose of 11 to 17 fluid ounces of SUPER ALGAE RAIDER per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of freshly cleaned and filled pool add initially 6 to 11 fluid ounces of SUPER ALGAE RAIDER per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of SUPER ALGAE RAIDER per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

SUPER ALGAE RAIDER is compatible with those chemicals normally used to treat pools and is effective at both acid and alkaline pH. SUPER ALGAE RAIDER can be used in pools treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix SUPER ALGAE RAIDER with concentrated dry or liquid chlorine products.

STORAGE: Keep container closed when not in use. Leaking or damaged containers should be placed in a plastic bag and discarded in trash. Mop up spills with clear water. All pesticides should be kept out of reach of children and stored away from food.
DISPOSAL: Do not reuse empty container. Wrap container and place in trash.
