

PRECAUTIONARY STATEMENTS

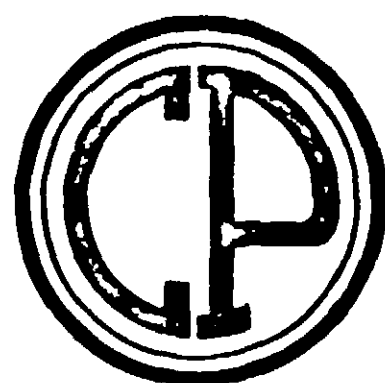
