The labeling referred to above, submitted in connection with redistration under the Federal Inserticide, Fungicide, and Rodenticide Act is acceptable provided you:

- Plate the changes below before releasing the product the shipment bearing amended labeling:
  - a. Under Storage and Disposal add the rollowing pesticide disposal language from PP Notice 80%, since this is a Toxicity Category I product:
    - "Pesticide wastes are acutely bacardous. Improper disposal of excess pesticide on rinsate is a violation of Federal law. If these wastes mannot be disposed of by use according to tabel instructions, contact your State Pesticide of Environmental Control Agency, of the Hazardous Waste representative at the pearest EPA Pegional Office for quidance."
  - b. Under Statement of Practical Treatment for swallowing we recommend the following:
    - "Drink promptly a large quantity of milk, ego white, gelatin solution, or if these are not available, large quantity of water. Note to Physician: the use of gastric lavage."

\*Note: Although the Registration Standard suggests inducing vomiting, this revised language reflects current Agency quidance regarding indesting of corrosive materials.
