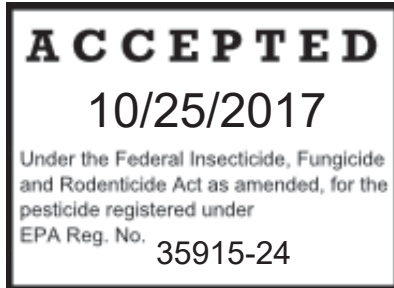

This product is for use only in the formulation of end-use herbicide products with the following uses: Arracacha, Asparagus, Cabbage, Cotton, Cucumber, Fallow cropland, Melon (muskmelon and watermelon), Mint, Pea (succulent), Pepper, Pumpkin, Rice, Snap Bean (succulent), Soybean, Squash, Sugarcane, Sweet potato, Tanier, Tobacco, and Yam. Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration; Uses for experimental purposes that are in compliance with USEPA requirements. Formulators using this product are responsible for obtaining EPA registration of their formulated product.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

PESTICIDE STORAGE: Store above 77°F to keep product from crystallizing. If product crystallizes, melt the product at temperatures lower than 185°F. Store in original container only. Open container carefully. After partial use, replace the lid and close tightly. Do not put concentrate or dilute material into food or drink containers. In case of spill, avoid contact. Isolate the area and keep out animals and unprotected persons. Confine spills by absorbing with sand, cat litter, or commercial clay.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER HANDLING – Nonrefillable container. Do not reuse or refill this container. Triple rinse [or pressure rinse] as follows: Triple rinse: Empty the remaining contents into a storage container or a mix tank. Fill the container 1/4 full with appropriate solvent*. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into a storage container for later use or disposal, or into a mix tank for product formulation. Repeat this procedure two more times. Then offer for recycling, if available, or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. **Pressure rinse:** Empty the remaining contents into a storage container or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over storage container or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

*An appropriate solvent would include a solvent that will dissolve technical material. The rinsate may be used later to formulate a product or may be disposed in accordance with local, state and national environmental laws, rules, standards and regulations.
