The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance

Asparagus, Beans (succulent and dry), Brassica head and stem vegetable Crop Group 5-16, Chinese broccoli, Cilantro/Coriander, Cottonseed subgroup 20C, Cucurbit vegetables crop group 9, Dill, Edamame, Fallow cropland, , Mint (peppermint tops, spearmint tops), Pea (succulent), Pepper, Rapeseed Subgroup 20A, Rhubarb, Rice, Soybean, Sugarcane, Tobacco, and Tuberous and corm vegetables (except potato) Subgroup 1D.

Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration;

Uses for experimental purposes that are in compliance with USEPA requirements.

Formulators using this product are responsible for obtaining EPA registration of their formulated product.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

STORAGE: Store above 77°F to keep product from crystallizing. If product crystallizes, melt the product at temperatures lower than 185°F. Store in original container only. Open container carefully. After partial use, replace the lid and close tightly. Do not put concentrate or dilute material into food or drink containers. In case of spill, avoid contact. Isolate the area and keep out animals and unprotected persons. Confine spills by absorbing with sand, cat litter, or commercial clay.

CONTAINER HANDLING – Nonrefillable container. Do not reuse or refill this container. Triple rinse [or pressure rinse] as follows:

Triple rinse: Empty the remaining contents into a storage container or a mix tank. Fill the container 1/4 full with appropriate solvent*. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into a storage container for later use or disposal, or into a mix tank for product formulation. Repeat this procedure two more times. Then offer for recycling, if available, or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Pressure rinse: Empty the remaining contents into a storage container or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over storage container or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

*An appropriate solvent would include a solvent that will dissolve technical material. The rinsate may be used later to formulate a product or may be disposed in accordance with local, state and national environmental laws, rules, standards and regulations.
