The amendment referred to above, submitted in connection with registration under the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), as amended is acceptable.

The basic and alternate #1 CSFs (both dated 02-19-13) are acceptable and have been added to your record as current and updated. The basic CSF (dated 02-19-13) must supersede all other basic CSFs on file. In addition, the product chemistry data for Group A and B are acceptable and a copy of the review is enclosed for your record.

The data requirements for storage stability (830.6317) and corrosion characteristics (830.6320) have not been satisfied, and must be submitted within 18 months of the date of this letter.

The label amendment is acceptable and a stamped copy of the label is enclosed for your record. This label supersedes all previously accepted labels. You must submit one (1) copy of the final label before you release the product for shipment. Products released for shipment after (18) months from the date of this letter must bear the new revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
