

6. Under "DIRECTIONS FOR USE", change "Consult Nufarm before using this product for formulating purposes." to "It is Nufarms intent that you consult Nufarm before using this product for formulating purposes."
7. Under "WARRANTY DISCLAIMER", second sentence add after "TO THE EXTENT CONSISTENT WITH APPLICABLE LAW" the phase ".....and except what is stated on this label....",
