

The proposed subject amendments to the registration of
"Dicamba Technical" have been reviewed and were found acceptable

Act(FIFRA), as amended, provided that you:

1. Revise the ingredient statement to comply with PR Notice 97-5; i.e., replace the chemical expression for dicamba with the CAS name: 3,6-dichloro-2-methoxybenzoic acid.
2. Submit one copy of the final printed labeling prior to shipping this pesticide product under the revised labeling.

If these condition are not complied with, this registration will be subject to cancellation in accordance with FiFRA, section 6(e). 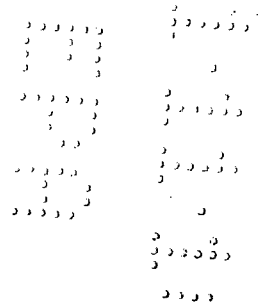

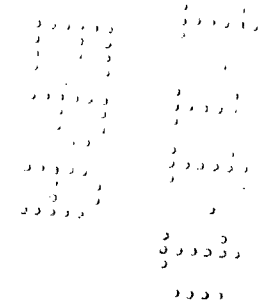
