This product is toxic to fish. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into manufacturing equipment and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over manufacturing equipment or collect rinsate for later use or disposal. Insert pressure-

rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Then, offer for recycling or reconditioning, or puncture and dispose in a sanitary landfill, or by other procedures approved by state and local authorities.
