3. Make the following label changes:
 - a. First Aid Statements: Per the Acute Toxicology review, make the following modifications:
 1. Move the "IF ON SKIN OR CLOTHING" statement to the first position
 2. Add the following "IF SWALLOWED" statement in the second position:
 - Call a poison control center or doctor immediately for treatment advice
 - Have person sip a glass of water if able to swallow
 - Do not induce vomiting unless told to by a poison control center or doctor
 - Do not give anything by mouth to an unconscious person
 3. The IF INHALED and IF IN EYES statements are optional.

Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove and was contaminated clothing before reuse."

4. Add the EPA Registration number 35935-74.

5. Submit one copy of the revised final printed label for the record.
