STATEMENT OF PRACTICAL TREATMENT

If product gets in eyes, flush with plenty of water for at least 15 minutes. Call a physician. In case of skin contact, wash thoroughly with soap and water. Remove and wash contaminated clothing before reuse. If product is swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or, if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in labeling.

Petro-HP is used in commercial and industrial recirculating cooling water potable water supply systems. It should not be used in preparation. Before treatment with Petro-HP begun, cooling water systems should be cleaned thorough deposits. Then they should be drained, refilled with water dose of 2.5 to 10.0 fluid ounces of Petro-HP per 1000 gallons of water in the system. Repeat until 0.5 to 10.0 fluid ounces per 1000 gallons of water needed. To control the growth of bacteria in industrial 0.5 to 5.0 fluid ounces of Petro-HP per 1000 gallons of water entering the system, continuous
