DIRECTIONS FOR USE  
GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ALGAEKILL is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness pools, spas, whirlpools, and hot tubs containing heavy growth of algae should be cleaned prior to using ALGAEKILL.

For pools having just visible algal growth add an initial dose of 75 to 116 fluid ounces of ALGAEKILL per 10,000 gallons of water and remove settled algal debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 41 to 75 fluid ounces of ALGAEKILL per 10,000 gallons of water. Subsequent additions of 13.6 to 27 fluid ounces of ALGAEKILL per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, or hot tubs having just visible algal growth require an initial dose of 8 to 12 fluid ounces of ALGAEKILL per 1000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, or hot tub, add initially 4 to 8 fluid ounces of ALGAEKILL per 1,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of ALGAEKILL should be made every 5 to 7 days after initial treatment for maintenance.

ALGAEKILL is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. ALGAEKILL can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix ALGAEKILL with concentrated dry or liquid chlorine products.

**STORAGE & DISPOSAL:** Keep container closed when not in use. Do not contaminate water, food, or feed by storage, disposal or cleaning of equipment. Rinse that cannot be used or reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. Open dumping is prohibited.
