DIRECTIONS

SURFACE APPLICATIONS

ROACHES, SILVERFISH, CRICKETS, ANTS, SPIDERS: Apply as a coarse spray directed into locations where these pests may hide: behind baseboards, moldings, cabinets, shelves, sinks, door and window frames, around plumbing, drains, and into cracks and crevices in walls. Whenever possible spray the pests directly. Remove or cover foodstuffs, utensils, or dishes. Repeat treatment as necessary.

FLEAS: Remove pets from rooms to be treated. Thoroughly vacuum floors and carpets and discard contents of bag. Apply spray as a fan pattern to the baseboards around the perimeter of each infested room. Also spray rugs, floors, cracks in floors, carpets, and the base of any furniture in the room. Treat around the legs and the undersides of the furniture and beds. Pay particular attention to those areas frequented by the pet. Do not apply this insecticide to asphalt tile or foam backed carpeting. Allow floors to dry completely before reoccupying the rooms. Replace pet bedding with fresh materials. Repeat treatment as necessary.

BEDBUGS: Spray liberally to top, ends, sides, and bottom of mattresses paying particular attention to all tufts, seams, and folds. Spray springs and frame directing the liquid into all cracks and lock joints. Treat walls, baseboards, moldings, floors, closets, bedroom furniture, picture frames, and other protected areas where bedbugs may breed or hide.

PANTRY PESTS: Accessible and exposed stages of saw-toothed grain beetle, red flour beetle, granary weevil, drug store beetle, cigarette beetle, confused flour beetle, cadelle, rice weevil, cheese mites, skippers, Angoumois grain moth, Indian meal moth, and Mediterranean flour moth. Inspect and destroy any infested food products. Thoroughly clean storage areas. A vacuum helps remove small particles. Apply this spray thoroughly to all surfaces of shelves, cabinets, bins, pantries, and similar food storage areas with particular attention to cracks, crevices, and other hiding places.

CLOTHES MOTHS AND CARPET BEETLES: Remove infested articles from storage; brush thoroughly and if possible air several hours in direct sunlight. Apply spray liberally in empty chests, closets, bureaus, and other storage areas directing liquid into cracks, joints, and crevices. After airing, infested articles may be treated by holding the spray nozzle at least three

3) feet away from the fabric and applying the liquid lightly to seams to avoid the possibility of staining. For Carpet Beetles treat both sides of rugs, carpets, and pads, and all exposed and accessible surfaces of over-stuffed furniture. Treat the edges of carpeting around the perimeter of each room and where possible direct the spray under the baseboards. Do not spray foam backed carpeting or foam padding as this may cause swelling. Repeat treatments as necessary.

SPACE SPRAY APPLICATIONS

FLIES, FRUIT FLIES, MOSQUITOES, GNATS, SMALL FLYING MOTHS, WASPS AND HORNETS: Close doors and windows and shut off ventilating systems. Make sure all open flames are extinguished. Apply using a good machine adjusted to deliver a fine mist. Direct spray toward upper portions of the room to fill the entire areas with mist. Using 1 to 2 ounces per 1000 cubic feet of space. Vacate the treated areas and ventilate before reoccupying. Keep the entire areas closed for ten minutes after treating. Repeat application when reinfestation occurs.

CAUTION

Harmful if swallowed. Avoid contamination of feed and foodstuffs. Do not pour, use, spill, or store near heat or open flame. Remove pets, birds and cover fish aquaria before spraying.

This product is toxic to fish. Keep out of lakes, streams or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as directed on the label. Do not reuse empty container or drum. Destroy empty container or drum by perforating or crushing and burying in a safe place away from water supplies. Empty drums may be returned to a drum reconditioner.

The use of this product in food processing plants should be confined to time periods when the plant is not in operation. Foods should be removed or covered before treatment. All food processing machinery and surfaces should be covered during treatment or thoroughly cleaned before using.
