PANEL A

STORAGE AND DISPOSAL

Prohibitions: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

Disposal: Do not reuse empty container. Wrap container and put in trash collection.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

APPLICATION METHODS

The use of this product in indoor residential settings is limited to spot and/or crack and crevice treatments. This product should be applied as a coarse (large droplet) spray. Treat where pests are found or normally occur. For spot treatments, an individual spot should not exceed two square feet.

ROACHES: Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts - behind sinks, into cracks and crevices, the underside of all drawers, baseboards, pipeholes in walls, and cracks of kitchen cupboards. Inspect and treat other areas in the house where infestation is evident. Pay particular attention to bathrooms, cracks and crevices in closets, dresser drawers and frames. Replace dishes, food and utensils only after shelves and cupboards have thoroughly dried.

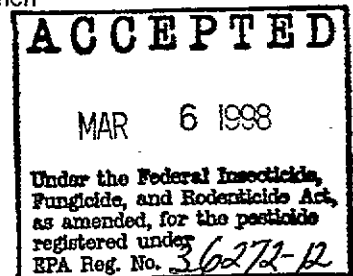
ANTS, SPIDERS, SILVERFISH, CRICKETS, AND EARWIGS: Spray areas where these pests are found or may hide including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry. Repeat treatment as required.

BROWN DOG TICKS: Spot treat infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of pets, and localized areas of floors and floor coverings. Repeat as necessary. Bedding should be replaced in animal quarters after treatment. Do not treat pets with this product. Rather, inspect and treat your pet with a product registered for animal application.

FLEAS: Remove pets from rooms to be treated. Vacuum floors and furniture in rooms where infestation is evident. Discard contents of bag. Spot treat floors and baseboards in infested rooms where the pets eat, sleep, and rest. Spot treat under furniture. Do not apply to the cushions of furniture or bedding. Do not treat pets with this product. Rather, inspect and treat your pet with a product registered for animal applications. This will help control the source of the infestation. Replace pet bedding with fresh materials after treatment. Allow treated areas to dry completely before reoccupying the room.

FLIES AND MOSQUITOES: Use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.
