

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

Prohibition: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

Disposal: Do not reuse empty container. Wrap container and put in trash collection.

This product should be applied as a coarse (large droplets) spray in spot treatment of localized surface areas only.

ROACHES: Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts - behind sinks, into cracks and crevices, the underside of all drawers, baseboards, pipes and walls and cracks of kitchen cupboards. Inspect and treat other areas in the house where infestation is evident. Pay particular attention to bathrooms, cracks and crevices in toasters, dresser drawers and frames. Replace dishes, food and utensils only after shelves and cupboards have thoroughly dried.

ANTS, SPIDERS, SILVERFISH, CRICKETS AND FARMERS: Spray areas where these pests are found or may be, including dark corners of rooms and closets, cracks and crevices along baseboards and soot sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant nests, nests and points of entry. Repeat treatment as required.

FLEAS AND MOSQUITOES: Use only on outdoor surfaces. Spray outdoors on areas of animals and their fixtures and other areas where these pests may enter the home. Fleas and mosquitoes clinging to nests on treated surfaces will be killed. Repeat treatment when effective coverage diminishes.

FLEAS AND BROWN DOG TICKS (INHABITANT): Thoroughly spray areas of infestation and spot treat all bedding such as pet beds and resting quarters, including cracks and crevices, along and behind baseboards, window and soot frames, and floor and walls of floor and floor covering where the pests may be present. Old bedding should be removed and replaced with clean fresh bedding after treatment. Do not treat pets with this product. Rather, inspect the animal for pest with a pair of registered for animal pest traps. This will help identify the source of the infestation.

Note to Physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.
