The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below:

In panel A, the heading Directions for Use along with the sentence "It is a violation of federal law....." should be moved right below Container Disposal and above the sentence " This product should be applied as a coarse....." As such it appears that directions for use to control various pests are a part of the Storage and Disposal section.

Five (5) copies the final printed labeling must be submitted prior to releasing the product for shipment bearing the amended labeling. A stamped copy of the label is enclosed for your records.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

**Storage:** Keep pesticide in original container. Store upright in a cool, dry place, away from children and pets, and preferably in a locked storage area. Avoid exposure to extreme temperatures and direct sunlight. Protect from freezing. Do not transport or store under 32°F. If crystallization occurs during storage, shake container until crystals disappear. In case of spill or leakage, soak up pesticide with absorbent material such as sand, sawdust, earth, kitty litter, etc. Dispose of with chemical waste.

**Product Disposal:** Pesticide, spray mixture, or rinse water that cannot be used according to label instructions must be disposed of at or by an approved waste disposal facility.

**Container Disposal** Do not reuse empty container. Wrap container in several layers of newspaper and discard in trash.

This product should be applied as a coarse (large droplet) spray in a spot treatment of localized surface areas only.

**ROACHES:** Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts - behind sinks into cracks and crevices, the underside of all drawers, baseboards, pipeholes in walls and cracks of kitchen cupboards. Inspect and treat other areas in the house where infestation is evident. Pay particular attention to bathrooms, cracks and crevices in closets, dresser drawers and frames. Replace dishes, food and utensils only after shelves and cupboards have thoroughly dried.

**ANTS, SPIDERS, SILVERFISH, CRICKETS AND EARWIGS:** Spray areas where these pests are found or may hide including dark corners or rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry. Repeat treatment as required.

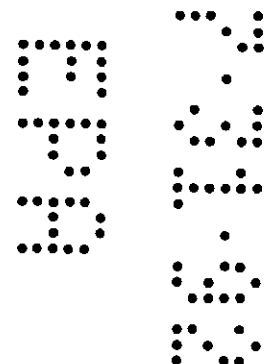


# PANEL A (CONTINUED)

**FLEAS AND BROWN DOG TICKS INDOORS:** Thoroughly apply as a fine mist and spot treat infested areas such as pet beds and resting quarters, near cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where the pests may be present. Old bedding should be removed and replaced with clean fresh bedding after treatment. Do not treat pets with this product. Rather, inspect and treat your pet with a product registered for animal applications. This will help control the source of the infestation.

**FLEAS AND BROWN DOG TICKS OUTDOORS:** For treatment of localized infestation of these insects in outdoor areas where there are weeds or brushy non-crop areas, spray infested areas thoroughly. Repeat applications as infestations warrant and as reinfestation occurs.

**FLIES AND MOSQUITOES:** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures or porches, in garages, and other places where these insects alight or congregate. Repeat as necessary.

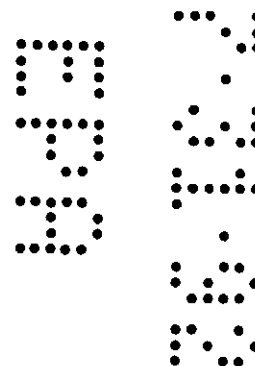

### PRECAUTIONARY STATEMENTS

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**CAUTION:** Harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from feed, foodstuffs and domestic water supplies. Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not use on household pets or humans. Remove pets and cover fishbowls before spraying. Do not smoke while using. Wash thoroughly after handling. Keep children and pets away from treated areas until surfaces are dry.

#### STATEMENT OF PRACTICAL TREATMENT

- IF SWALLOWED:** Call a physician or poison control center. Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting to an unconscious person.
- IF ON SKIN:** In case of contact, remove contaminated clothing immediately. Wash skin with plenty of soap and water.
- IF INHALED:** Remove victim to fresh air. Apply respiration if indicated.
- IF IN EYES:** Flush eyes with plenty of water.

**Note to physician:** Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

#### ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams and ponds. Do not apply where runoff is likely to occur. Do not apply when weather favors drift from treated areas. Do not apply directly to water. Do not contaminate water by cleaning equipment or disposal of equipment washwater. Apply this product only as specified on this label.

PHYSICAL OR CHEMICAL HAZARDS

Do not pour, use, spill or store near heat or open flame. Do not spray on wallpaper or let material run down painted walls. Do not spray on or near electrical outlets, switches or junction boxes.
