**DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

**STORAGE AND DISPOSAL**

Do not store or transport below 32 F.

**Prohibitions:** Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

**Pesticide Disposal:** Pesticide spray mixture or residue that cannot be disposed of according to label instructions must be disposed of according to federal, state or local procedures under the Resource Conservation and Recovery Act.

**Container Disposal:** Triple rinse (or equivalent) and offer for recycling or reconditioning, or dispose of in a sanitary landfill, or by other approved state and local procedures.

This product should be applied as a coarse (large droplet) spray in spot treatment of localized surface areas only.

**ROACHES AND WATERBUGS:** Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts, behind sinks, into cracks and crevices, the under side of all drawers, baseboards, pipe-holes in walls and cracks of kitchen cupboards. Inspect and treat other areas in the house where infestation is evident. Pay particular attention to bathrooms, cracks and crevices in closets, dresser drawers and frames. Replace dishes, food and utensils only after shelves and cupboards have thoroughly dried.

**ANTS, SPIDERS, SILVERFISH, CRICKETS, EARWIGS, FIREBRATS, CENTIPEDES, MILLIPEDES, SOMBUGS AND SPRINGTAILS:** Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators, and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests, and points of entry. Repeat treatment as required.

**PANTRY PESTS (Acrescible and exposed stages of saw-toothed grain beetles, red flour beetles, granary weevils, rice weevils, cigarette beetles, and drug store beetles):** Destroy infested grain products. Remove dishes and utensils. Thoroughly vacuum and clean cupboards. Spray underside of shelves, cracks and crevices, and the underside of drawers. Allow shelves to dry before replacing foodstuffs, dishes and utensils.

**CARPET BEETLES:** Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks and infested areas of shelving in closets. Repeat as necessary.

**BROWN DOG TICKS INDOORS:** Thoroughly apply as a fine mist and spot treat infested areas such as pet beds and resting quarters, near cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where the pests may be present. Old bedding should be removed and replaced with clean fresh bedding after treatment. **Do not treat pets with this product.**

**FLIES, SMALL FLYING MOTHS, MOSQUITOES, WASPS:** For outdoor use only as an aid in reducing annoyance from these pests. Spray outside surfaces of screens

doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures or porches, in garages and other places where these insects alight and congregate.

**FLEAS, CHIGGERS, ANTS:** For treatment of localized infestation of these insects in outdoor areas, spray weeds and bushy non-crop areas around the home thoroughly. Avoid spraying desirable plants. For ants, thoroughly wet hills and runways. Repeat applications as infestations occur and as reinfestations occur.

**PRECAUTIONARY STATEMENTS**  
**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION:** Harmful if swallowed. May be absorbed through the skin. Avoid breathing of spray mist. Avoid contact with skin, eyes or clothing. Wash thoroughly after handling and before eating or smoking. Do not allow spray to contact feed, foodstuffs or milk supplies. Thoroughly wash dishes and food handling utensils if contaminated by this spray. Remove pet and cover fish bowls before spraying. **STATEMENT OF PRACTICAL TREATMENT**

- IF SWALLOWED: Call a physician or poison control center immediately. Drink one or two glasses of water and induce vomiting by touching the back of throat with finger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person.
- IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.
- IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water.
- IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.
