# MYSTIC ROACH and household INSECT SPRAY II

### DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

### STORAGE AND DISPOSAL

**Prohibitions:** Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

**Disposal:** Do not reuse empty container. Wrap container and put in trash collection.

This product should be applied as a coarse (large droplet) spray in spot treatment of localized surface areas only.

**ROACHES:** Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts - behind sinks, into cracks and crevices, the underside of all drawers, baseboards, pipes/holes in walls, and cracks of kitchen cupboards. Inspect and treat other areas in the house where infestation is evident. Pay particular attention to bathroom, cracks and crevices in closets, dresser drawers and frames. Replace dishes, food and utensils only after shelves and cupboards have thoroughly dried.

**ANTS, SPIDERS, SILVERFISH, CRICKETS AND EARWIGS:** Spray areas where these pests are found or may hide including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry. Repeat treatment as required.

**FLIES AND MOSQUITOES:** Use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

**FLEAS AND BEDBUGS, TICKS AND INSECTS:** Thoroughly apply as a fine mist and spot treat infested areas such as pet beds and resting quarters, near cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where the pests may be present. Old bedding should be removed and replaced with clean fresh bedding after treatment. Do not treat pets with this product. Rather, inspect and treat your pet with a product registered for animal applications. This will help control the source of the infestation.

### PRECAUTIONARY STATEMENTS

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if swallowed. Avoid contact with eyes, skin, and clothing. Avoid breathing vapors or spray mist. Keep away from feed, foodstuffs and domestic water supplies. Do not use in edible products areas of food processing plants, restaurants, or other areas where food is commercially prepared or prepared. Do not use in serving areas while food is exposed. Do not use on household pets or humans. Remove pets and cover fish bowls before spraying. Do not smoke while using. Wash thoroughly after handling. Keep children and pets away from treated areas until surfaces are dry.

#### STATEMENT OF FIRST AID TREATMENT

**IF SWALLOWED:** Do not induce vomiting. Contain an aromatic petroleum solvent. Call a physician immediately.  
**IF ON SKIN:** In case of contact, remove contaminated clothing and immediately wash skin with plenty of soap and water.  
**IF IN EYES:** Flush eyes with plenty of water.

Note to Physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

#### ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams and ponds. Do not apply where it is likely to occur. Do not apply when weather favors drift from treated areas. Do not contaminate water by cleaning equipment or disposal of wastes. Apply this product only as specified on this label.

#### PHYSICAL OR CHEMICAL HAZARDS

Do not pour, use, spill or store near heat or open flame. Do not spray on or toward asphalt or plastic tile or rubber-backed carpeting.
