

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

DISPOSAL: Do not reuse empty container. Wrap container and put it in trash collection.

PESTICIDE DISPOSAL: Pesticide, spray mixture or rinsate that cannot be disposed of according to label instructions must be disposed of according to federal, state or local procedures under the Resource Conservation and Recovery Act.

CONTAINER DISPOSAL: Triple rinse (or equivalent) and offer for recycling or reconditioning, or dispose of in a sanitary landfill, or by other approved state and local procedures.

SHAKE BEFORE USING

This product should be applied as a coarse (large droplet) spray in a spot treatment of localized surface areas only.

ROACHES: Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts - behind sinks, into cracks and crevices, the underside of all drawers, baseboards, peepholes in walls and cracks of kitchen cupboards. Inspect and treat other areas in the house where infestation is evident. Pay particular attention to bedrooms, cracks and crevices in closets, dresser drawers and frames. Replace dishes, food and utensils only after shelves and cupboards have thoroughly dried.

ANTS, SPIDERS, SILVERFISH, CRICKETS, EARWIGS, CENTIPEDES, MILL-BORES AND SCORPIONS: Spray areas where these pests are found or may hide including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry. Repeat treatment as required.

FLEAS AND BROWN DOG TICKS Indoors: Thoroughly apply as a fine mist and spot treat infested areas such as pet beds and resting quarters, near cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where the pests may be present. Old bedding should be removed and replaced with clean fresh bedding after treatment. Do not treat pets with this product. Rather, inspect and treat your pet with a product registered for animal applications. This will help control the source of the infestation.

FLEAS AND BROWN DOG TICKS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas where there are weeds or bushy non-crop areas, spray infested areas thoroughly. Repeat applications as infestations recur and as reinfestation occurs.

FLEAS, BOGGRYTES, GNATS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surface around light fixtures or porches, in garages, and other places where these insects alight or congregate. Repeat as necessary.

CLOTHING MOTHS AND CARPET BEETLES: Spray edges of carpeting and under carpeting, rugs and closets. Make localized application to the floor and baseboards. Spray directly into cracks and crevices, closets and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat if necessary.

PRECAUTIONARY STATEMENT

HAZARD TO HUMANS AND DOMESTIC ANIMALS

Harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from feed, foodstuffs and domestic animal supplies. Do not use in eating products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not use on household pets or humans. Remove pets and cover fishbowl before spraying. Do not smoke while using. Wash thoroughly after handling. STATEMENT OF FIRST AID TREATMENT

- IF INHALED: Remove victim to fresh air. Apply respiration if indicated.
