PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from feed, foodstuffs and domestic water supplies. Do not use in edible product areas of food processing plants, restaurants or other area where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not use on household pets or humans. Remove pets and cover fishbowls before spraying. Do not smoke while using. Wash thoroughly after handling. Keep children and pets away from treated areas until surfaces are dry.

FIRST AID

IF SWALLOWED: Call a physician or poison control center. Drink one or two glassed of water and induce vomiting by touching back of throat with finger. Do not induce vomiting to an unconscious person.

IF ON SKIN: In case of contact, remove contaminated clothing immediately. Wash skin with plenty of soap and water. Get medical attention.

IF IN EYES: Flush eyes with plenty of water for 15 minutes. Get medical attention..

IF INHALED: Remove victim to fresh air. Apply respiration if indicated. Get medical attention.

Note to Physician: Contains petroleum distillate. If gastric lavage is deemed necessary, undertake only after proper placement of a cuffed endotracheal tube. Active ingredients contain a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams and ponds. Do not apply where runoff is likely to occur. APPLICATION METHODS

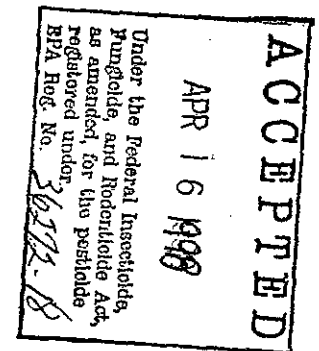
The use of this product in indoor residential settings is limited to spot and/or crack and crevice treatments. This product should be applied as a coarse (large droplet) spray. Treat where pests are found or normally occur. For spot treatments, an individual spot should not exceed two square feet.

ROACHES: Remove all dishes, food and utensils from the area to be sprayed. Make spot applications to infested roach haunts - behind sinks, into cracks and crevices of kitchen cupboards. Inspect and treat other area in the house where infestation is evident. Pay particular attention to bathrooms, cracks and crevices in closets, dresser drawers and frames. Replace dishes, food and utensils only after shelves and cupboards have thoroughly dried.

ANTS, SPIDERS, SILVERFISH, CRICKETS, EARWIGS, CENTIPEDES, PILLBUGS AND SCORPIONS: Spray areas where these pests are found or may hide including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry. Repeat treatment as required.

FLEAS AND BROWN DOG TICKS INDOORS: Remove pets from rooms to be treated. Vacuum floors and furniture in rooms where infestation is evident. Discard contents of bag. Spot treat floors and baseboards in infested rooms where the pets eat, sleep, and rest. Spot treat under furniture. Do not apply to the cushions of furniture or bedding. Do not treat pets with this product. Rather, inspect and treat your pet with a product registered for animal applications. This will help control the source of the infestation. Replace pet bedding with fresh materials after treatment. Allow treated areas to dry completely before reoccupying the room.

FLIES, MOSQUITOES, GNATS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames, or where ever these insects may enter the room. Also treat surfaces around light fixtures or porches, in garages, and other places where these insects alight or congregate. Repeat as necessary.

FLEAS AND BROWN DOG TICKS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas where there are weeds or bushy non-crop areas, spray infested areas thoroughly. Repeat application as infestations warrant and as reinfestation occurs.

CLOTHES MOTHS AND CARPET BEETLES: Spray edges of carpeting and under carpeting. Rugs and closets. Make localized applications to the floor and baseboards. Spray directly into crack and crevices, closets and infested areas of shelving, and/or wherever these insects are seen or suspected. Repeat as necessary.
