If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of the Act.


We will no longer accept a label declaration of 100 percent pure active ingredient for any chlorinated derivative of cyanuric acid, because results obtained from modern analytical techniques show that the purity of these products is closer to 99.00 percent or thereabouts, depending on the quality control procedures exercised by different manufacturers. Therefore, the label for this product must be revised to declare 99.00 percent active ingredient and 1.00 percent inert ingredients.

Other labels which have been accepted with a declaration of 100 percent will be required to be revised, at an appropriate time, when these labels come up for a general revision to comply with current requirements.

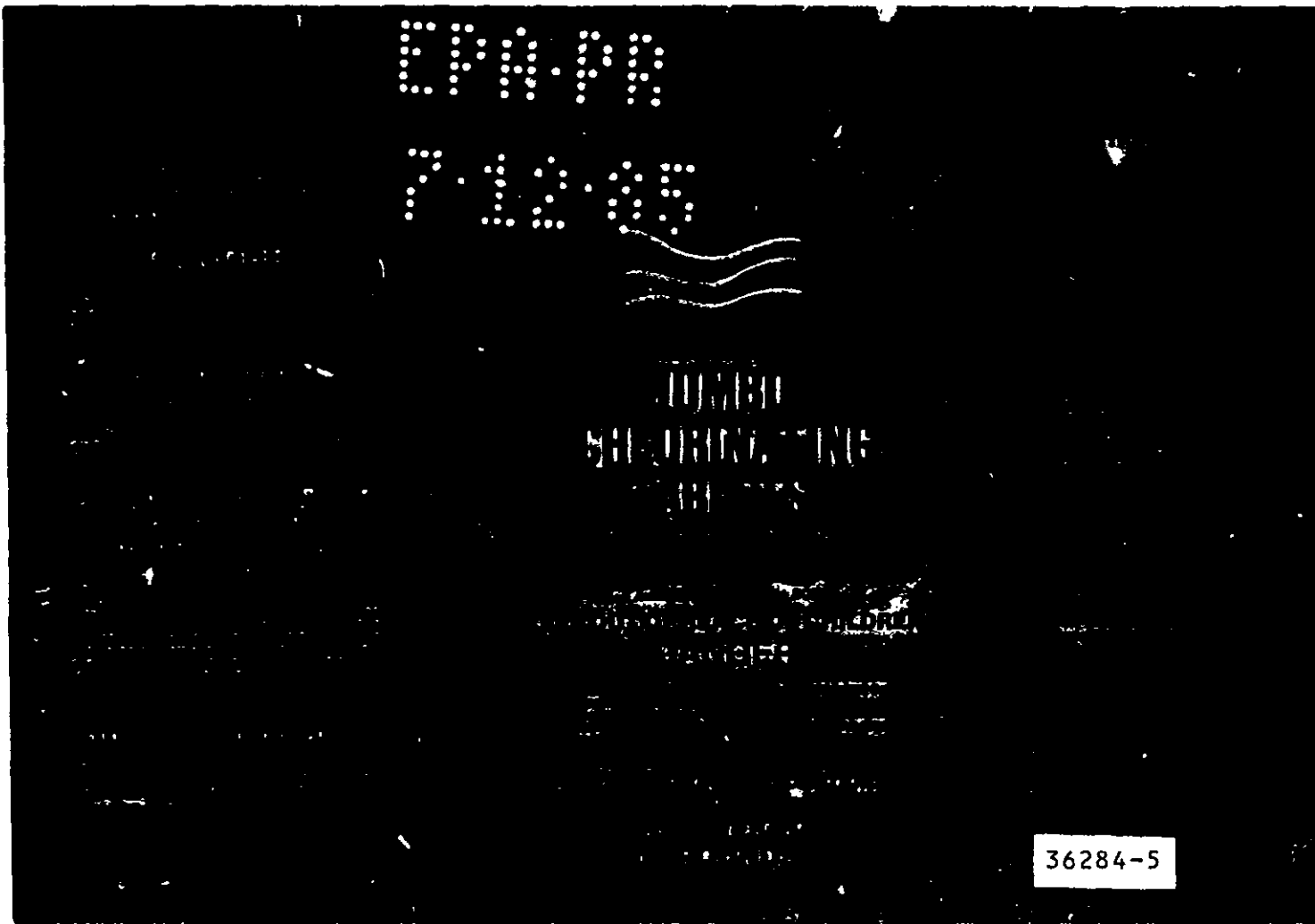
