1. The Registration Number which has been assigned to this product must appear on the label as EPA Registration No. 36306-12.
2. Change "For Industrial, Commercial or Medical Use Only" to read "For use in industrial, commercial, or medical areas only."
3. Change "face mask" to "face shield."
4. Complete the net contents statement.
5. The labels which will be used for this product in channels of trade must reflect these revisions.
6. Five copies of the finished printed labels, as defined in the A-79 Enclosure, must be submitted to the Agency before the product is released for shipment to comply with FR Notice 82-2 of June 18, 1982.
7. The finished printed labels must comply with the general labeling requirements of Section 162.10 of Title 40 of the Code of Federal Regulations. If the label does not satisfy these requirements it will be rejected.
