DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Ultracide 60

In swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and hot tubs with heavy growth of algae should be cleaned prior to use.

For pools having just visible algae growth add 6 fluid ounces of Ultracide 60 per 10,000 gallons of water. For treatment of a pool with heavy settled algae debris by clearing. For treatment of a pool add initially 6 to 11 fluid ounces of Ultracide 60 per 10,000 gallons of water. Subsequent additions of Ultracide 60 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 1 to 2 fluid ounces of Ultracide 60 per 1000 gallons of water. For treatment of a hot tub or decorative fountain, add initially Ultracide 60 per 1,000 gallons of 0.2 to 0.4 fluid ounces of Ultracide 60 should be made every 5 to 7 days after initial treatment.

Ultracide 60 is used to treat pools, spas, and decorative fountains with an alkaline pH. Ultracide 60 decorative fountains treated with chlorine chemicals normally required. However, do not mix with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag or lined with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty containers.
