The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provision:

# Addition of Alternate Text comment(s), bottom of page 1 of 3:

1. Revise the statement "[Pyrethrum from Rwanda – Simply the Best]" located directly beneath the SOPYRWA logo to read: "[Pyrethrins from Rwanda]."

SOPYRWA/Whitmire Micro-Gen Research Laboratories, Inc. should note that a notice of availability of EPA's reregistration eligibility decision (RED) document for products containing pyrethrins was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42387-42389). As a result, additional data and/or labeling changes may be required for products containing pyrethrins.

Please submit two (2) copies of the final printed labeling, incorporating the above change, before releasing the product for shipment. If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes accepting of this condition. A stamped copy of the label for this product is enclosed for your records.
