The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

- 1. Delete "Berliner" and replace "var." with "subsp." in the ingredients statement.
- 2. Move the Keep Out of Reach of Children statement above the signal word, Caution, and provide type that conforms with the point size requirements of 40 CFR 156.10(h).
- 3. Delete the statement "This product appears to have no adverse effects on earthworms or on beneficial insects such as ladybugs and praying mantids." Such statements are only acceptable if data supporting them, for all life stages of the beneficial insects listed, are submitted and found to support such claims by the Agency.
 - 4. Delete "...since there appear to be no harmful residues."
- 5. Modify the active ingredient percentage in the ingredients statement from "0.3%" to "0.05%." This change is necessary since your label claims a potency of 240 IU/mg product. [(240/500,000) (100%) = 0.048%]

- Add the statement "Potency units should not be used to adjust use rates beyond those specified in the directions for use section." at the beginning of the application rates section.
- 8. Your last stamped approved label had tobacco as a target crop. Per your conversation and agreement with Mike Mendelsohn of my staff, add tobacco and associated pests (tobacco budworm, loopers, hornworms) to your master label.
- Submit a copy of your current Confidential Statement of Formula within 45 days of the date of this letter.

Note that this acceptance of your label does not relieve you of your obligation to comply with the Worker Protection Standard. If any of your products are covered by this standard, you are required to submit, and receive the Agency's approval by April 21 1994, a revised label reflecting the required label statements of 40 CFR 156, published in the FEDERAL REGISTER on August 21, 1992 (57FR 38102). Further guidance will be issued. According to 40 CFR 156, subpart K: "No product to which this subpart applies shall be distributed or sold without amended labeling by any registrant after April 21, 1994.
