


SHAKE WELL BEFORE EACH USE.

TO Kill Flies, Mosquitoes, Moths, and other flying insect pests: Prior to application, close doors and windows in the area being treated. Hold container upright and spray upward in a sweeping motion to all parts of the room. Treat areas around windows and other light sources since flying insects are attracted to these areas. Leave room after spraying. Keep doors and windows closed for 15 minutes after treatment. Ventilate room when treatment is complete. Repeat treatment as necessary.

To Kill Cockroaches, Ants, and Spiders: Spray insects directly to kill on contact. Treat all areas infested with insects. Spray surfaces until wet, paying special attention to cracks, crevices, areas around drains and pipes, around appliances, along baseboards, and any other locations where insects may be hiding. Contact as many insects as possible as they are driven into the open from hiding places. Repeat treatment as necessary.

When treating for ants, spray ant trails, areas around doors and window frames and any other locations ants may be seen entering. Repeat treatment as necessary.

This product is non-staining to most surfaces. Do not use on surfaces that may be damaged by water. If unsure, first treat an inconspicuous area and check in a few hours for staining or damage.
