Instructions For Use — NOMATE PBW™ is intended for use in preventing pink bollworm damage in cotton. This is accomplished by interfering with mating communication between adult moths. By disrubting the natural mating process, fertile egg alaying and subsequent larval infestations can be suppressed and reduce the need for the use of conventional chemicals.

Rate of Application

The rate of application should be from 15 to 30 grams per acre per application.

5. Monitoring should begin in fields at planting time using pheromone baited traps (or other suitable means) to detect the number of pink bollworm moths.

Monitoring moth flights to detect population change should continue throughout the growing season on a 1-3 day schedule.

- 2. The first application of NOMATE PBW™ should be made after insect emergence and at the time (or shortly before) plants produce the first set of squares (buds).
- 3. Subsequent applications should be made based on the following factors or combinations of them.
- a. When field monitoring for pink bollworm moths shows that mating disruption may be weakening as indicated by male moths attracted to pheromone traps or other suitable monitoring systems.
- Plant growth of approximately 6 inches since the last application.
- c. Early in the season when daily field temperatures are below 100°F (38°C) the interval between successive applications should not exceed 21 days. Later in the season when daily field temperatures are 100°F and above, the interval between successive applications should not exceed 10 days.
- 4. If for any reason damage to the crop by pink bollworm or other insects begins to approach or exceeds acceptable levels, the use of alternate methods of control should be considered. If conventional insecticides are used on a regular basis, it is recommended that NOMATE PBW^{IM} treatments be terminated for the remainder of the season. Local agricultural extension service personnel may be able to provide information on pest insect economic thresholds. Field Application

Ground and air application of NOMATE PBW™ requires specially designed equipment available from Conrel. Local custom applicators have this equipment and are prepared to provide application services.

- 1. With ground equipment, NOMATE PBW^{IM} should be applied as near the terminal bud and asseventy through the field as possible. During early stages of plant growth, it may be more effective and efficient to make applications by ground rather than air to insure proper placement of material.
- 2. With air application equipment, applications should be made by flying across planting rows (if possible) and fiber distribution should be as even as possible. A flying altitude of 15-50 feet is recommended with the higher altitude being flown when ground winds are still or moderate and lower

altitudes flown as necessary to compensate for high ground wind conditions,

- 3. Applications can be made at any time of day.
- 4. Each application of NOMATE PBW™ is designed to last an average of 14 days in the field at 100 degrees F. Cooler temperatures may extend the effectiveness. Severe environmental conditions including wind and rain storms which can cause fibers to be knocked off the plants and unusually high temperatures causing accelerated evaporation may reduce the longevity of NOMATE PBW™. For this and other reasons fields must be closely monitored to determine when applications are required. 5. Bio-Tac, an inert sticker material, is available from Conrel or Conrel distributors, and should be used in conjunction with NOMATE PBW™. Its purpose is to hold individual fibers on the cotton foliage, Before inixing with Bio-Tac, keep cans of NOMATE PBWIM sealed and in a cool place. Just prior to application, mix NOMATE PBW™ and Bio-Tac one (1) part NOMATE PBW™ with two (2) parts Bio-Tac by volume. Mix only the amount to be used immediately. The mixture should be applied according to applica-
