INSTRUCTIONS FOR USE

NoMate® CRS Spiral is intended to prevent damage to citrus crops such as oranges, lemons, limes, grapefruit, tangerines, clementines, and any crop CRS is present.

The product functions by disrupting the mating communication between the sexes of the adult moths.

RATE OF APPLICATION

The rate of application is 180 dispensers per acre (450 per hectare). Use the spirals in 1-3 applications per year as needed. Do not exceed 150 grams of active ingredient per acre per year.

METHOD OF APPLICATION

NoMate® CRS Spiral is applied directly by wrapping the spiral around the stems or branches. Open the bag just prior to application. Apply product to the inner part of canopy and in the middle of the tree.

For maximum effectiveness, it may be necessary to increase the density of the dispenser placement around the orchard perimeter.

TIMING OF APPLICATION

Monitor using Scentry Pheromone lures and Traps to determine the time of application. Make the first application within 2 to 4 days after the first male moth is captured in a trap (biofix). Prediction Degree Day Models can provide assistance in determining application timing. Model information and economic thresholds may vary according to geographical regions, consult local extension offices and crop advisors in the area for more information.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed through storage or disposal. Pesticide Storage: Store in a cool place until used. Prolonged storage should be at or less than 40° F (4° C). Pesticide Disposal: Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility. Container Disposal: Nonrefillable container. Do not reuse or refill this container. Dispose of empty bag in the trash.
