DIRECTIONS FOR

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Poolside 2001 is

used for the treatment of algae in swimming pools, exterior spas, whirlpools, hot tubs, and indoor swimming pools. Spas, whirlpools, hot tubs, and hot tubs with heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial dose of Poolside 2001 fluid ounces of Poolside 2001 per 10,000 gallons of water. For treatment of pools with settled algae debris by cleaning. For treatment of pools with heavy growth of algae add initially 41 to 75 fluid ounces of Poolside 2001 per 10,000 gallons of water. Subsequent additions of Poolside 2001 per 10,000 gallons of water should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains should be treated with an initial dose of 8 to 12 fluid ounces of Poolside 2001 per 1,000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4 fluid ounces of Poolside 2001 per 1,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of Poolside 2001 should be made every 5 to 7 days after initial treatment.

Poolside 2001 is compatible with other chlorine chemicals and may reduce the amount of chlorine required. However, do not mix Poolside 2001 with other liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of reach of children and away from food.

DISPOSAL: Do not reuse empty container. Wipe out container with water.
