

DIRECTIONS

After pool is closed in the evening (Sunday evening preferred) pour 1 gallon of SUPER SHOK for each 10,000 gallons of water directly into pool and shut off filter. The following morning start filter and vacuum pool. Do not use pool until active chlorine residual has dropped to 3.0 ppm or less as determined by a suitable test kit. Repeat this treatment weekly or after a heavy rain or after a heavy bathing load.

SUPER SHOK will raise pH. Use test kit, if pH is above 7.6 ppm reduce by adding Sinco pH reducer (follow directions on label). Add 1 pint (16 oz.) for each 10,000 gallons of pool water, pH must be maintained between 7.2 and 7.6 ppm at all times. If necessary repeat procedure until proper pH level is reached.

This product is toxic to fish. Treated effluent should not be discharged where it will drain into lakes, streams, ponds or public water. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.

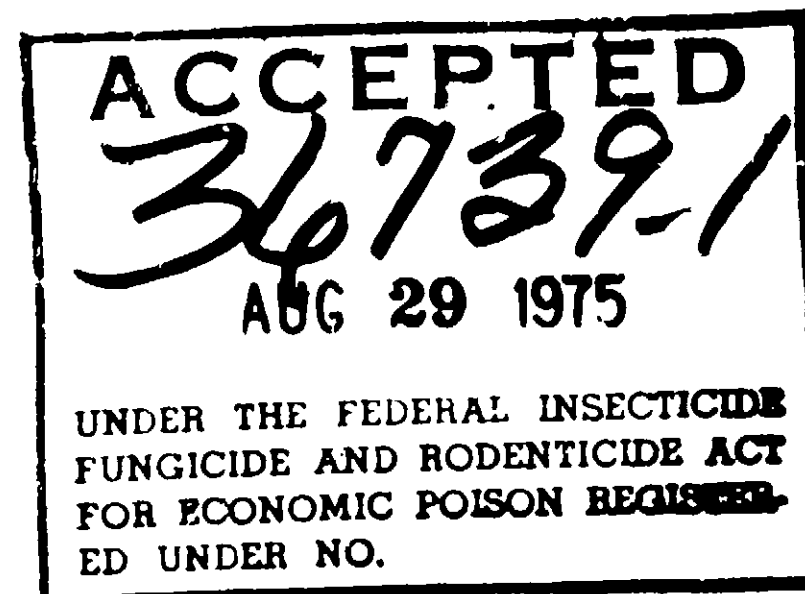
CAUTION
