**DIRECTIONS FOR SWIMMING POOL CHLORINATION:**  
For a new pool or for spring start-up, superchlorinate with this sodium hypochlorite solution for each 2500 gallons of water to 5 ppm available chlorine by weight.  
For Pool Maintenance:  
A) Adjust pool water pH to 7.6 - 7.2 range and maintain.  
B) Add manually or by a feeder device this sodium hypochlorite solution to maintain an available chlorine residual of 0.6 to 1.0 ppm of this sodium hypochlorite solution for each 6000 gallons of water. Frequency of application will depend upon temperature. Use test kit to make certain the pH and chlorine residual are maintained.

**DIRECTIONS FOR DISINFECTION OF PUBLIC WATER SUPPLY:**  
Dilute this sodium hypochlorite solution in the ratio of 1 part solution to 9 parts softened water. Mix sodium hypochlorite solution thoroughly and begin feeding of solution with a hypochlorite feeder to maintain an available chlorine residual of at least 0.2 ppm throughout the distribution system, as determined by a biological sampling must be conducted at a frequency of 100 ppm available chlorine will depend upon temperature. Use test kit to make certain the pH and chlorine residual are maintained.

**DIRECTIONS FOR SANITIZING FOOD PROCESSING EQUIPMENT:**  
Clean equipment in the normal manner. Just before use, wash with this sodium hypochlorite solution containing 200 ppm available chlorine for a minimum of two minutes after treatment with sodium hypochlorite solution. Do not use one fluid oz. (2 tbsp.) of this sodium hypochlorite solution to provide approximately 200 ppm available chlorine by weight.

**NOTE:** This product degrades with age. Use a chlorine test kit as necessary, to obtain the required level of available chlorine.  
**STORAGE AND DISPOSAL:** Store in original container from direct sunlight. In case of spill, flood area with water. Empty container thoroughly with water and either return to original container or place in trash collection or burying in an approved landfill. Cannot be used, should be diluted with water and disposed of so as not to contaminate food or feed by storage, disposal or use.

**DIRECTIONS FOR SWIMMING POOL CHLORINATION**  
For a new pool or for spring start-up, superchlorinate with one (1) pint (16 flu. ozs.) of this sodium hypochlorite solution for each 2500 gallons of water. This dosage is equivalent to 5 ppm available chlorine by weight.  
**For Pool Maintenance:**  
A) Adjust pool water pH to 7.6 - 7.2 range and maintain.  
B) Add manually or by a feeder device this sodium hypochlorite solution at a rate to maintain an available chlorine residual of 0.6 to 1.0 ppm. One-half pint (8 flu. ozs.) of this sodium hypochlorite solution for each 6000 gallons of water will provide 1.0 ppm available chlorine by weight. Frequency of additions to maintain 0.6 to 1.0 ppm available chlorine will depend upon temperature and number of swimmers. Use test kit to make certain the pH and chlorine residual are in the proper range.

**DIRECTIONS FOR DISINFECTION OF POTABLE WATER  
FOR HOME WELL WATER SYSTEMS**  
Dilute this sodium hypochlorite solution in the ratio of one part sodium hypochlorite solution to 9 parts softened water. Mix sodium hypochlorite solution and water thoroughly and begin forcing of solution with a hypochlorinator (metering pump). Maintain a free available chlorine residual of at least 0.2 ppm and no more than 0.5 ppm throughout the distribution system, as determined by a DPD chlorine test kit. Bacteriological sampling must be conducted at a frequency no less than that prescribed by the National Interim Primary Drinking Water Regulations. Check water frequently with a DPD chlorine test kit. Contact your local Health Department for further details.

**DIRECTIONS FOR SANITIZING FOOD PROCESSING OR DAIRY EQUIPMENT**  
Clean equipment in the normal manner. Just before using, rinse all surfaces thoroughly with this sodium hypochlorite solution containing 200 ppm available chlorine. Maintain contact with disinfectant for a minimum of two minutes. Do not rinse with water after treatment with sodium hypochlorite solution. Do not use overnight. Addition of one fluid oz. (2 tblsp.) of this sodium hypochlorite solution per 4 gallons of water will provide approximately 200 ppm available chlorine by weight.

**NOTE:** This product degrades with age. Use a chlorine test kit and increase dosage, as necessary, to obtain the required level of available chlorine.  
**STORAGE AND DISPOSAL:** Store in a cool, dry area away from direct sunlight. In case of spill, flood area with large quantities of water. Rinse empty container thoroughly with water and either return to manufacturer or discard by placing in trash collection or burying in an approved landfill. Product or rinseate that cannot be used should be diluted with water and disposed of in a sanitary sewer. Do not contaminate food or feed by storage, disposal or cleaning of equipment.
