STATEMENT OF PRACTICAL TREATMENT-IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists. IF SWALLOWED: Call a physician or Poison Control Center Drink 1 or 2 glasses of water and induce vorniting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vorniting.

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Causes eye Irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling. Animals: Do not use on lactating animals or animals that are less than 8 weeks of age. In case of infection or skin irritation, discontinue use and consult a veterinarian.

STORAGE AND DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Pesticide storage: Do not store below 32 degrees F. If frozen, thaw and shake well. Container Disposal: Triple rinse and, if available, offer for recycling or re-conditioning. Alternatively, securely wrap container in several layers of paper and discard in trash.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Wet pet thoroughly with luke warm water. Pour small amount of KENIC TRI-EX FLEA AND TICK SHAMPOO on pet. Work from head (avoid contact with eyes and mouth) to hindquarters and legs until coat is completely covered with lather. As a precaution, a bland ophthalmic ointment can be placed in the eyes of the pet prior to bathling to prevent possible irritation. Let stand for 5 minutes then thoroughly rinse. Restrain pet from licking coat while shampoo is acting. For extreme cases of flea and tick infestation the above process may be repeated. May be used as often as every 3 to 5 days depending on severity of infestation. May be used full strength or diluted with up to 4 parts of water. For complete control of external parasites fleas, ticks, lice) use KENIC FLEA RID PYRETHRIN CLEAR DIP or KENIC FLEA RID PYRETHRIN SPRAY
