It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Strike Bac 10% Pool Algaecide is used to control algae in swimming pools, exterior spas, whirlpools, hot tubs, and decorative fountains. Pools, spas, whirlpools, hot tubs, and decorative fountains should be cleaned prior to using Strike Bac 10% Pool Algaecide.

For pools having just visible algae growth add an initial dose of 8 to 12 fluid ounces of Strike Bac 10% Pool Algaecide per 10,000 gallons of water. For treatment of a freshly cleaned and filled pool, add 4 to 8 fluid ounces of Strike Bac 10% Pool Algaecide per 10,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of Strike Bac 10% Pool Algaecide per 10,000 gallons of water should be made every 5 to 7 days after initial treatment.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 8 to 12 fluid ounces of Strike Bac 10% Pool Algaecide per 10,000 gallons of water. For treatment of a freshly cleaned and filled decorative fountain, add initially 4 to 8 fluid ounces of Strike Bac 10% Pool Algaecide per 10,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of Strike Bac 10% Pool Algaecide should be made every 5 to 7 days after initial treatment.

Strike Bac 10% Pool Algaecide is compatible with liquid chlorine products. It can be used to treat pools, spas, and decorative fountains and is effective against algae. Strike Bac 10% Pool Algaecide can be used in pools treated with chlorine chemicals and may reduce the amount of chlorine required. However, do not mix Strike Bac 10% Pool Algaecide with liquid chlorine products.

**STORAGE AND DISPOSAL**

**STORAGE:** Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of reach of children and away from food.

**DISPOSAL:** Do not reuse empty container. Wrap in plastic and dispose of with clear water.
