

Disposal. Do not use empty container. Wrap container and put in trash collection.

To kill flies, mosquitoes and gnats: Close room and discharge spray mist vigorously in all parts of rooms using about 2 or 3 ounces for each 1,000 cubic feet or room space. Leave room closed for at least 15 minutes. Ventilate room thoroughly before re-entry. Sweep up and discard fallen insects. Repeat as needed.

To kill cockroaches and waterbugs: Apply in all cracks and crevices in woodwork, underneath sinks, behind pipes and in all places suspected of harbouring these insects. Contact as many insects as possible. Repeat as needed
