Avoid getting dust in eyes, nose and mouth of animal. Do not use on nursing animals. Do not use on pregnant dogs and cats. Repeat treatment as necessary.

Directions For Use (continued):

PUPPIES AND KITTENS

Do not use on puppies and kittens under 4 weeks of age. For puppies and kittens over 4 weeks of age, treat the same as described for dogs and cats.

PET'S SLEEPING QUARTERS

For kennels and living quarters, dust bedding and floor at the rate of 1 oz. per 50 sq. ft. of surface. Repeat as needed.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry location. Do not contaminate water, food or feed by storage or disposal. Keep cap tightly closed when not in use to avoid moisture absorption. Do not transfer contents to other containers.

DISPOSAL: Do not reuse container. Wrap container in newspaper and put in trash.
