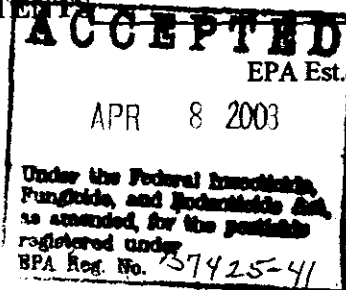

#### **DOGS AND CATS**

Remove safety cap and insert sprayer. Cover animal's eyes with hand and with a firm, fast stroke to get a proper spray mist, spray head, ears and chest until damp. With fingertips, rub into face around mouth, nose and eyes. Then spray neck, middle and hindquarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long haired dogs, rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure spray thoroughly wets ticks. Do not over-saturate, especially on cats. Avoid spraying genital areas. If problems arise seek veterinary assistance. For a complete flea and tick control program consult your veterinarian. Repeat every 3 weeks.

#### **NURSING PUPPIES AND KITTENS**

Spray only along back or on your fingertips and run into coat.

#### **STORAGE AND DISPOSAL**

**STORAGE:** Store in a cool, dry area away from heat or open flame. Do not contaminate water, food or feed by storage or disposal. Do not transfer contents to other containers.

**DISPOSAL:** **If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
