WARNING

DOGS AND CATS

To prevent harm to you or your pet, read entire label before use. Consult your veterinarian before using this product on pregnant or lactating females, old, sick, or debilitated animals, or on animals undergoing drug or other pesticide treatment. Cover animal's eyes with hand and with a firm, fast stroke to get a proper spray mist, spray head, ears and chest until damp. With fingertips, rub into face around mouth, nose and eyes. Then spray neck, middle and hindquarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long-haired dogs, rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure spray thoroughly wets ticks. Repeat treatment as needed.

AND KITTENS**
