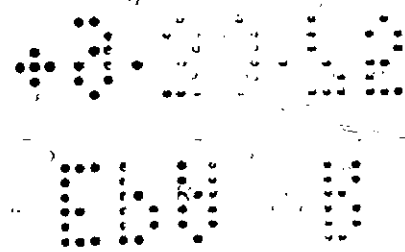

DIRECTIONS FOR USE

Do not use this material in water intended for domestic or irrigation purposes. Use this material only in landlocked or enclosed lakes or ponds. Do not exceed a maximum application rate of 1 lb. per surface acre. Before application be sure to check for permit requirements with the nearest Fisheries Division, Department of Natural Resources offices. Following treatment the water should not be used for any recreational or irrigation purposes for ten (10) days.

SPECIFIC APPLICATION DIRECTIONS: Apply this product at a rate of 1/2 to 1 pound per surface acre. Make application by mixing with sufficient water from the lake to be treated to cover the surface area evenly. Application can be made by trailing a hose in the water from the boat or with a spray attachment as the boat is driven in such a fashion to distribute the material as evenly as possible over the entire body of water. Sufficient control can be achieved from ponds less than one (1) acre by distributing the material in dry form from the shore. Application of the material should be made when the first indications of filamentous algae build up is observed.

Preventive treatment of a lake is not recommended. Applications should not exceed one (1) application per year. If the material is applied too early, season long control might not be obtained.

IMPORTANT: Injury to or loss of desirable plants or trees may result from the draining or flushing equipment on or near areas where the roots may extend or locations where the chemical may be washed or moved into contact with their roots. Any application equipment intended for other uses must be thoroughly cleaned immediately after use. Flush tank, pump, hoses and nozzels. Do not re-use container. Crush and bury when empty.
