The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable.

The alternate brand name: Berries Quality has been added to the registration. Our records have been updated accordingly. This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by EPA. If the website is false or misleading, the product will be considered to be misbranded and sale or distribution of the product is unlawful under FIFRA section 12(a)(1)(E). 40 CFR § 156.10(a)(5) lists examples of statements the EPA may consider false or misleading. 

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. To assure freshness by the fungicidal control of *Botrytis cinerea* on [table grapes] (or) [blueberries].

1. Do not use defective pads (e.g., torn pad or broken seal).
2. Use a polyethylene liner in an appropriate shipping container.
3. Place the pad above the fruit, fold the polyethylene liner over the pad and close the container.
5. Place the boxes of packed [grapes] (or) [blueberries] in refrigerated storage at 0-2°C.
6. Remove the pad from case before display of [grapes] (or) [blueberries] for sale or after removal of container from retail store refrigeration facilities.
7. If the pad is torn, remove pad and damaged [grapes] (or) [blueberries] and hold remainder of contents for 24 hours before displaying.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Keep this product dry in a tightly closed container, when not in use. Store in a cool, dry, well-ventilated area away from heat and flame.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: In case of decomposition, isolate container (if possible) and flood area with large amounts of water to dissolve all material before discarding this container.
