## **PRECAUTIONARY STATEMENTS**

Hazard to Humans and Domestic Animals:

**CORROSIVE:** Causes irreversible eye damage and skin burns. Fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. **PHYSICAL OR CHEMICAL HAZARD:** Oxidizing Material. Avoid contact with combustible materials. Keep away from all sources of heat, flame, or sparks. At elevated temperatures (above about 325°F) a self propagating thermal decomposition may occur with resultant irritating and toxic gases. In case of fire, flood with large quantity of water. Empty residue into application equipment. Then offer for recycling if available or dispose of liner in a sanitary landfill or by incineration. If drum is contaminated and cannot be reused, dispose of it in the same manner required for its liner.

**CONTAINER DISPOSAL:** Non-refillable container. Do not reuse or refill this container. Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then offer for recycling, if available, or dispose of liner in a sanitary landfill or by incineration. For outer container triple rinse container (or equivalent) promptly before emptying. Then offer for recycling, if available or puncture and dispose of in a sanitary landfill, or by incineration.

**CONTAINER DISPOSAL:** Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Then offer for recycling, if available or puncture and dispose of in a sanitary landfill, or by incineration.
