The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Antimicrobials Division (AD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10. The label submitted with the application has been stamped "Notification" and will be placed in our records.

In addition, this letter serves as notice that the current label contains statements and/or images that were inadvertently approved by the Agency during its previous review. Please submit a revised label amendment addressing the inadvertently approved items below within 60 days of receipt of this letter.

1. The Precautionary Statement should read as follows:

CORROSIVE: Causes irreversible eye damage and skin burns. Fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. Harmful if swallowed. Do not get in eyes, on skin or on clothing. Wear goggles or face shield, protective clothing and rubber gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and was before reuse.

2. The routes of exposure must appear in the following order based on toxicity profiles: If in eyes, If on skin, If inhaled and If swallowed

ENVIRONMENTAL HAZARD: This pesticide is toxic to fish and aquatic organisms.
