Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. 

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

The plugging of drip irrigation emitters is a universal problem which will cause a lack of water application uniformity. One of the primary causes of emitter plugging is the proliferation of bacteria and algae within the lines and emitters of a drip irrigation system. Bacti-Chlor is an additive which controls both algae and bacterial growth resulting in a uniform distribution of water. The amount of Bacti-Chlor required for injection into the irrigation water to supply a desired dosage in ppm can be calculated by the following equation: I = gallons of Bacti-Chlor injected/hour.

I = (0.006) (ppm desired) (system flow rate in gallons per minute) /0.11

With a D.P.D chlorine test kit determine the residual chlorine at the emitter farthest from the injection pump. The residual chlorine should be between 1.0 - 2.0 ppm with a water pH of 7.2 - 7.6.
