DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner

MID-WEST-ALGAECIDE is used in swimming pools, exterior spas, whirlpools, hot tubs, etc. that do not contain fish. For maximum effectiveness pools, decorative fountains, and ponds containing heavy growth of algae should be treated with MID-WEST-ALGAECIDE.

For pools having just visible algae growth add an initial dose of MID-WEST-ALGAECIDE per 10,000 gallons of water. Remove settled algae debris by cleaning. For treatment of a pool, add initially 27 to 50 fluid ounces of MID-WEST-ALGAECIDE per 10,000 gallons of water. Subsequent additions of 9 MID-WEST-ALGAECIDE per 10,000 gallons of water should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, decorative fountains, and ponds with algae growth require an initial dose of 5 to 10 fluid ounces of MID-WEST-ALGAECIDE per 1000 gallons of water. In a cleaned spa, whirlpool, hot tub, decorative fountain, or pond, add 5 fluid ounces of MID-WEST-ALGAECIDE per 1000 gallons of water. Subsequent additions of 1 to 2 MID-WEST-ALGAECIDE should be made every 7 days for maintenance.

MID-WEST-ALGAECIDE will prevent algae growth during the off-season winter months when pools are not in use. For pools only treated during the swimming season and are free of algae, add 43 fluid ounces of algicide per 10,000 gallons of water. If season pools have some visible algae growth, add 50 fluid ounces per 10,000 gallons. It is necessary that a uniform distribution of water and the pool be made for maximum effectiveness. If necessary to repeat the treatment one or more times during the season.

MID-WEST-ALGAECIDE is compatible with other chlorine products used to treat pools and spas and is effective at low concentrations. MID-WEST-ALGAECIDE can be used in conjunction with chlorine chemicals and may reduce the amount of those chemicals required. However, do not mix MID-WEST-ALGAECIDE with other chlorine products.

STORAGE & DISPOSAL: Do not contaminate water, food, or feed. Keep container closed when not in use. Leaking or damaged containers should be placed in a plastic bag and discarded in trash. Most pesticides should be kept out of reach of children. DISPOSAL: Do not reuse empty container. Wrap or burn.
