## I. Manufacturing Process and Confidential Statement of Formula:

The revised manufacturing process and Confidential Statement of Formula (CSF), referred to above, submitted in connection with registration\_under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, are acceptable with the following comments:

- 1. The Total Weight in block 17 of the CSF should be 1671.9 kg. Please make this correction on your copy of the CSF.
- The "% by Weight" of the active ingredient, MCPA, in column 13b of the CSF should be 96.6. Please make this correction on your copy of the CSF.

A copy of the CSF (Basic Formulation), dated 4/12/96, has been placed in our file for the subject product. This CSF supersedes all other CSFs submitted for this product.

## II. Revised Label:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided you:

1. Revise the ingredient statement as follows to agree with the new CSF:

Active Ingredient:

	2-Methyl-4-chlorophenoxyacetic acid

2. Revise the Oral Statement of Practical Treatment to read as follows:

"IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelation solution, or if these are not available, drink large quantities of water. Avoid alcohol."

This change is consistent with EPA's latest policy as outlined in the Label Review Manual. We believe it is medically unadvisable to induce vomiting in cases where a pesticide product has been ingested, if the product is in Toxicity category I for eye irritation. Due to the corrosiveness of such products, there is a concern that additional tissue damage might occur during vomiting. Except in cases where the product also has a high acute oral toxicity, EPA believes the risk of additional damage outweighs the risk of toxicity from the ingested substance. Since the subject product has a relatively low acute oral toxicity (Toxicity category III), vomiting should not be induced if the product is ingested.

A stamped copy of the labeling is enclosed for your records. Please submit one copy of your final printed labeling before you release the product for shipment.
