Precautionary Statement Hazards to Humans and Domestic Animals

CAUTION

Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.

Do not apply directly to food. In commercial food handling facilities, cover or remove any food and food processing equipment during application. Do not apply while food processing is underway. After space spraying in meat packing plants, bakeries and other food processing plants, wash all equipment, benches, shelving, etc., where exposed food will be handled, with potable water. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use.

Remove pets, birds and cover fish aquariums before spraying.

STORAGE AND DISPOSAL

DIRECTIONS:

For controlling House Flies, Mosquitoes, Gnats: Close windows and doors. Fill room with mist. Spray toward ceiling in all directions. Leave room closed for ten or fifteen minutes. It is frequently desirable to sweep up and destroy the fallen insects at the close of the ten minute period. Re-open windows and doors and let fresh air in before occupying.

For Ants: Spray freely and directly on insects if possible. Then spray around baseboards, doors, sills and window frames where pests may enter premises.

For Fleas: Use same directions as for ants. In addition, spray frequently the sleeping quarters of animals. Treat floors and floor coverings.

For Use in Air Vaporizers or Aerosol Sprayers. Follow instructions given on particular type unit to be used.
