INITIAL APPLICATION FOR SWIMMING POOLS

(To A Clean Pool)

Two gallons to each 50,000 gallons of water or ratio thereof. If Algae growth is visible apply the initial dose. If algae is still visible repeat dose as necessary until pool is free of visible algae.

CONTINUED APPLICATION

Two quarts in 50,000 gallons of water every 3-8 days or as needed to maintain 2 ppm active. Quaternary Test Kits are available for this use.

BOOSTER APPLICATION

Two quarts in 50,000 gallons after a heavy or prolonged rainfall or when there is a heavy bathing load.

The above directions should be followed even when the pool is not in use.

* If algae growth is noticeable, apply the initial dose.
